CHIEF EXECUTIVE OFFICER'S REPORT
JANUARY 2016**

ECONOMIC HIGHLIGHTS

On December 16, 2015 the Executive Board of the International Monetary Fund (IMF) completed the tenth review of Jamaica's economic performance under the current programme, supported by a four-year, SDR \$615.38 million arrangement under the Extended Fund Facility (EFF). According to Mr. Min Zhu, Deputy Managing Director and Acting Chair, on one hand the authorities continue to have an impressive track record of strong programme implementation under the EFF. He highlighted that macroeconomic stability continues to strengthen, vulnerabilities have reduced substantially, structural reforms have progressed and Jamaica has made important achievements under the economic programme. He added that with macroeconomic stability well-established, the recalibration of fiscal and monetary targets should help support growth and job creation. On another hand, fiscal sustainability requires continued reduction in the government wage bill and safeguarding revenues. In this regard, concrete efforts are needed to modernize the public sector and improve the efficiency of public services.

The United States' federal fund rate is the rate at which banks offer to lend to each other overnight. On December 15, 2015 Janet Yellen, Chair of the US Federal Reserve, announced that there will be an increase in the federal fund rate. The US Federal Reserve action moves the range of rates between 0.25% and 0.5%. An increase or decrease in the rate is said to have a domino effect as this will impact the loans rates at which banks lend their customers. In this case, an increase could result in higher borrowing costs for developing economies, many of which are already seeing slow growth. According to the BBC news, there are concerns that a rise will compound that slowdown, as higher rates in the US could strengthen the dollar, the currency in which many countries and companies borrow.

At the end of December 2015, the value of the Jamaican Dollar depreciated by J\$0.38 or 0.32% to J\$120.24=US\$1.00, while the Canadian dollar and the Great Britain pound appreciated by J\$4.30 and J\$3.83 respectively. At the end of the month, the Jamaican dollar value relative to the CAD\$1.00 and GBP£1.00 was JA\$84.91 and JA\$177.12 respectively.

Inflation, measured by the All Jamaica "All Divisions" Consumer Price Index (CPI) increased by 0.2% for the period December 2015 over November 2015. The increase in the rate brought inflation for the calendar year (January to December) to 3.7% and inflation for FY-to-December to 4.3%. The average rate per month at the end of December 2015 was 0.3%.

Data for the month ending December 2015 revealed that the stock of Net International Reserves (NIR) at the Bank of Jamaica was J\$279.46 billion (US\$2,437.27 million). This reflected an increase of J\$10.77 billion (US\$93.93 million) relative to November 2015.

The monetary base expanded by J\$12.12 billion or 11.0% to J\$122.21 billion for December 2015 relative to the previous month.

On the last trading day in December 2015, for the period December 01, 2015 to December 31, 2015, the main JSE index advanced by 10,518.16 points or 7.50% to close at 150,692.13 points. The JSE Combined Index advanced by 11,293.21 points or 7.68% to close at 158,269.14 points. The JSE Junior advanced by 152.59 points or 9.31% to close at 1,791.05 points. In contrast, the JSE Cross Listed Index remained firm

and closed the month at 499.06 points.

For November 2015 relative to October 2015, yields on GOJ 30-day and 90-day treasury bills increased by 30bps and 72bps respectively. However, yields on the 182-day treasury bill decreased by 3bps.

For November 2015, the production of Alumina was 156,188 tonnes. This represented a decrease of 7,193 or 4.40% tonnes, relative to October 2015. For the month, the sale of alumina amounted to 136,418 tonnes. This represented a decrease of 27,881 tonnes or 16.97% relative to October 2015. The production of crude bauxite, which is bauxite mined for exports, for November 2015 was 268,500 tonnes. This is an 81,200 tonnes or a 23.22% reduction from the 349,700 tonnes recorded in October this year.

The overall weighted average lending rate on domestic currency loans increased to 17.01% from 16.99% at the end of October 2015, relative to September 2015. For the month of October, the foreign currency loans rate increased relative to September 2015. In this regard, the rate rose by 5bps to 7.30%.

Stopover tourist arrivals for October 2015, was 134,317. This month's total is 20,037 or 17.53% higher than the 114,280 recorded in September 2015.

There were price reductions observed in 57% (12) of the commodities monitored for December 2015. The price of both crude oil indices decreased in December 2015 - the Brent fell by 15.08% and the WTI by 12.68%. Natural gas decreased by 7.69%.

CORPORATE GOVERNANCE COMMITTEE

No meeting was held for the month of January. However, the committee members were very active in finalizing corporate governance documents for the Broadcasting Commission and training for ECLOF. Also the committee members worked on finalizing the MSME CG Code.

STANDING COMMITTEE ON NATIONAL SECURITY

Highlights of the meeting held on Tuesday, January 19:

Crime Stop Report

It was reported that the year ended with 678 tips, in comparison to 2014 which had 548 tips. That is an increase of one hundred and thirty (130) tips. There is a clear-up rate of one in every six (1:6) calls. There were arrests made for illegal installation of electricity and also persons having sexual relations with minors (children under 16 years of age).

Private Security Regulator Authority (PSRA) Report

It was reported that the work of the board of the Private Security Regulator Authority (PSRA) has been concentrating on getting the necessary legislative amendments prepared for submission to the Minister. They were working on a Memorandum of Understanding (MOU) between the Private Security Industry, the Jamaica Constabulary Force (JCF) and the PSRA to foster greater cooperation and joint efforts.

Law and Order Working Group Report

It was reported that there has been two meetings of the committee, an informal one which was held shortly after the announcement and a formal meeting which was held on January 18, 2016 at Jamaica House. The working group's road map focused initially on the justice system and delivering justice. This includes the access of justice, the process to justice and also the timeliness in the delivery of justice.

Two documents have been presented to the working group from the Private Sector Organisation of Jamaica and the Jamaican Bar Association (which outlined 12 items which need to be dealt with).

There is an intention to increase the number of Justices of the Peace (JP) to be trained to sit in petty session courts and that there were legislative changes coming to increase the types of matters that can be heard in petty session courts.

JCF Report

It was reported that there have been changes in the JCF organizational structure, where major changes have been made in the Operations Department, these being:

- Territorial Operations Department now being headed by Deputy Commissioner George Quallo, giving him control of Police Areas One to Five.
- Strategic Operations Department now being headed by Deputy Commissioner Clifford Blake who will have oversight of the Community Safety and Security Branch, Mobile Reserve, Police Control, the ports, Traffic Division, Marine Police, Motorised Patrol Divisions, among others.

JCF Crime Statistics

The crime statistics for the period January 1 – January 16, 2016 were summarised and compared to the same period last year as follows:

- Murders – 34 were recorded: this represents a decrease of -18 or -35%
- Shootings – 32 were recorded: this represents a decrease of -8 or -20%
- Rape – 20 were recorded: this represents a decrease of -28 or -58%
- Aggravated Assault – 22 were recorded: this represents a decrease of -20 or -48%

In terms of Acquisitory Crime

- Robberies – 52 were reported: this represents a decrease -48 or -48%
- Break ins – 37 were reported: this represents a decrease of -62 or -63%
- Larceny – 10 were reported: this represents a decrease of -14 or -58%

Divisions of Concern:

- St. James reported 4 murders: this represents no change from 2015
- St. Ann reported 4 murders: this represents an increase of 3 or 300%
- Clarendon reported 4 murders: this represents a decrease of -1 or -20%
- Kingston Central reported 3 murders: this represents an increase of 2 or 200%

CRIME STOP

The Crime Stop Coordinator's report highlighted the following for the month of January 2016:

- The number of calls received was 31, 8 less than what was received in December.
- The success ratio was 1 in 64, in comparison to 1 in 6 in December.
- Two arrests were made, while five were made in December.
- The number of calls made to 311 was 29, 10 less than what was received in December.

ENERGY COMMITTEE

Highlights of the meeting held on Wednesday, January 27:

Renewable Energy RFP

Mr. Paul Scott and Mrs. Eleanor Jones advised the committee that January 27 was the opening ceremony for the RFP at the Petroleum Corporation of Jamaica.

Petrojam Fuel Prices

Mr. Chung reported that he, along with Mr. Mahfood, have been stepping up the ante concerning fuel prices. He noted that they were able to meet with Petrojam on January 26, 2016 for a relatively short meeting. The committee was further advised by Mr. Chung that Petrojam would be coming to the PSOJ to work with him, along with the JMA, to go through the details of the numbers concerning their pricing mechanism. He further stated that they agreed to this meeting and discussion on the basis that it is kept confidential.

Retrofitting of the PSOJ

Mr. Chung informed the committee that the retrofitting of the PSOJ has not been finalized. He noted that the electricity bill for the PSOJ has been reduced by approximately 60%; he said that this reduction can be attributed to the use of LED lights and the installation of more efficient air conditioning units.

Mr. Pijuan Mota noted that the net billing programme was still suspended making it difficult to determine if the PSOJ would go solar or not. Mr. Chung indicated that Minister Paulwell had said that he would reinstate the net billing programme by the end of January. The committee agreed that if this deadline was not met then they would have to do a follow up with the Minister.

Environment:**Climate Change Adaptation Fund**

Mrs. Jones mentioned that as the first Caribbean country to qualify for the fund, the pilot has been an embarrassment due to falling behind in the range of spend (which she noted has slightly picked up) and the fact that they had to seek an extension.

Mrs. Jones also expressed the issue of sand being removed from Negril. She also shared the contradictions which exist with issues concerning the environment; she cited the example of the removal of sand from the beach in Negril, the same area in which the adaptation fund is to be used to correct erosion. In response to Mrs. Jones' concern, Mr. Scott suggested that the committee write to Minister Pickersgill.

Mr. Chung raised the issue of possible corruption related to the removal of the sand. He recommended that in addition to the letter to the Minister, that a letter also be done to the Contractor General so that an investigation can be launched into the issue. Mr. Scott suggested that the Minister be invited to the PSOJ to speak on the issue. Mr. Chung said that the PSOJ would write to him to ascertain the earliest date in which he can meet with the PSOJ.

Rain Water Security/Harvesting:

Mr. Scott updated the committee that a presentation is to be made to the DBJ on the grounds of funding the project. Mr. Chung also inquired as to whether or not the PSOJ should be probing what the NWC is doing to mitigate the ongoing drought. Mr. Scott suggested adding the issue of water security to the discussion to be had with Minister Pickersgill.

Update on ESET Committee

Mr. Scott said that the OUR will have an oversight committee of which the Director General would be one member and there would be seven other individuals called commissioners. He explained that the committee will be chaired by Joe Matalon and Jimmy Lawrence will be the PSOJ representative.

Mr. Dan Theoc noted that with the new OUR Act as well as the Electricity Act, Government will now be able to give policy directives to the OUR. Mr. Scott noted that this was not limited to electricity but also telecommunications and water. He further stated that the issue of the privatization of water and sewage plants is also a topic to be discussed with Minister Pickersgill.

Mr. Scott shared with the committee that ESET will continue to exist with Chair Vinn Lawrence. He noted that ESET would act as the oversight for structural changes which have been agreed upon such as the gas agreement and building of the plants.

Mr. Pulido provided the committee with an update on the issue of 'bad gas'. He noted that due to the complaints, the Government has appointed a committee chaired by Noel Dacosta. Mr. Pulido advised that the report was not yet complete and he is to meet with the committee tomorrow (January 28, 2016). Mr. Scott, with the approval of the committee, decided that after the report is completed and received, the committee will decide if actions need to be taken.
