Second Biennial Jamaica Statistics Symposium and Pre-Conference Workshops, October 27-30, 2015

Held on 27-30, October 2015 at the Mona Visitor's Lodge and Conference Centre UWI, the Jamaica Statistics Symposium and Pre-Conference workshop Series (JASSYM 2015), organized by The Jamaica Statistical Society was a huge success. JASSYM 2015 was aimed at highlighting appropriate ways of handling data when preparing and using it for policy development. Representatives of key organizations were present at the opening ceremony including Dr. Cliff Riley from the Scientific Research Council, Dr. Delano Lewis from Northern Caribbean University, Prof. Ishenkamba Kahwa from the University of the West Indies and Professor Colin Gyles from the University of Technology. The Feature lecture was presented by the Director General of the Planning Institute of Jamaica (PIOJ) Mr. Collin Bullock.

High quality research and technical papers were presented. The presentations were divided in two categories Oral and Lightning Poster Oral. Feature Presentations included: "Statistical Methods for Grants and Protocols: What Information Should be Conveyed?" which was given by Dr. Jonathan D. Mahnken, Director of the Data Management and Statistics Core, The University of Kansas Alzheimer's Disease Center. "Meta-analysis: Planning, Implementation and Interpretation" by Dr. Chris Barker, President and Owner, Statistical Planning and Analysis Services, Inc., USA and "Approaches to Handling Time to Event Data" which was done by Dr. Karan P. Singh, Prof. in the Division of Preventive Medicine (DPM) and Director of the Biostatistics and Bioinformatics Shared Facility, University of Alabama, Birmingham. Other presenters included persons from the Ministry of Finance, UWI and UTech in Jamaica; other Caribbean countries as well as persons from Central and South America.





Pre-Conference Workshop Series (JASSYM 2015)

Data Analysis using Microsoft Excel and R Statistical Workshop was held on October 27, 2015. This workshop was facilitated by Mrs. Natalie Guthrie-Dixon from the University of Technology and Mr. Richard Plummer from the University of the West Indies. This workshop featured descriptive and inferential data analysis methods and compared how these were implemented in both statistical programmes. A total of thirty-two persons were in attendance. These participants were from government agencies & ministries, academic institutions and private sector agencies.
